

Privacy Policy

RONAL AG, Lerchenbühl 3, 4624 Härkingen, Switzerland and its subsidiaries (“**RONAL**”) is committed to protecting your personal information. RONAL will collect, process and use your personal data exclusively in compliance with the following statutory data protection provisions.

The company responsible for the operation of this Website (“**Website**”) is Speedline Truck S.R.L., a subsidiary of RONAL AG, with registered domicile Viale 1° Maggio 30, 24030 Presezzo (BG), Italy (“**SPEEDLINE TRUCK**”). This Website, which is operated purely for information purposes, presents up-to-date information about SPEEDLINE TRUCK as well as about the products and services offered by SPEEDLINE TRUCK. Under certain circumstances, when you visit this website, some of your personal data may be collected and stored by us. We will explain this to you in detail below:

1. General

- 1.1. Personal data is all information relating to an identified or identifiable natural person (“**Data**”). This includes, for example, your name, your telephone number as well as your postal and e-mail address.
- 1.2. It is essentially the case that we do not collect, process or use any of your Data if you visit our Website for information purposes only.
- 1.3. If you use our contact form or contact us by any other means, the entered Data will be stored by us to process your enquiry (as well as any possible follow-up questions). We will not pass this Data on to any third party without your consent.

The Data entered in your contact form or otherwise disclosed will be retained by us until

- you instruct us to erase this,
- you withdraw your consent to storage,
- or the purpose for the data storage is no longer applicable (e.g. after the processing of your request has been completed).

Statutory retention periods remain unaffected by this.

The Data you enter in the contact form or which you provide to us in the event of other contacts will be processed on the basis of your consent in order to answer your enquiry. You can revoke this consent at any time – a simple notification by e-mail sent to dataprivacy.it@ronalgroup.com or by letter to the contact address specified under Fig. 5.

The lawfulness of the data processing procedures performed before consent is revoked will not be affected by the revocation.

- 1.4. You can also contact our distribution partners directly via our Website. Please note that your enquiry will be submitted directly to the distribution partner and that SPEEDLINE TRUCK does not have any access to your enquiry or influence over the subsequent data processing.

2. Web analysis and cookies, social plug-ins

- 2.1. We use co-called “cookies” when you visit our website. Cookies are small text files that stored by your browser. Cookies do not contain any information that could directly identify the individual user. You can deactivate the use of cookies in the settings of your respective browser program, or can delete these automatically or manually. In this event, however, our Website might not function or might no longer function as intended.
- 2.2. Where appropriate, we may use some of your data stored via cookies in accordance with the statutory requirements on pseudonymous user profiles for purposes of market research or to tailor our services to your needs.
- 2.3. We also use the web analysis tool Google Analytics by Google (Google Inc., USA) on our Website to compile anonymous user statistics. Google Analytics uses Cookies. Generated information is processed in the USA only in exceptional cases. Data protection laws in the USA are not equivalent to those in Italy. To ensure the protection of your personal data in cases in which data is transferred to the USA, we use a function that processes our IP address in truncated form in order to prevent a direct link to your person. If you have any concerns relating to the use of Google Analytics, you may block Google Analytics by installing e.g. a plug-in in your browser. A plug-in for the most common browsers can be downloaded here: <http://tools.google.com/dlpage/gaoptout?hl=de>.

- 2.4. In addition, our Website uses functions of various social networks (“**Social Plug-ins**”).
- 2.5. Social Plug-ins are buttons on our Website. When you visit our Website, these buttons do not send any Data to the respective social networks without your intervention. Only when you click on a button will a direct connection be established with the server of the respective social network, which can collect Data and set cookies.
- 2.6. If you are logged in to a social network, this can assign the accessing of this Website to your user account. A social network cannot assign a visit to other RONAL websites unless you have also activated the respective button there.
- 2.7. We do not have any influence on the scope of data that is collected by social networks through their buttons. The purpose and scope of the data collection and the further processing and use of the data by the respective social networks as well as your associated rights and setting options to protect your privacy are set out in the data protection notices of the respective social networks.
- 2.8. We use Social Plug-ins of the following social networks:

 - Twitter Inc. (www.twitter.com, Headquarters, 1355 Market Street, # 900, San Francisco, CA 94103, USA, Data Protection Officer EU: Twitter International Company, attn.: Data Protection Officer, One Cumberland Place, Fenian Street, Dublin 2, D02 AX07, Ireland).
- 2.9. If you are a member of a social network and do not want the provider to collect and possibly combine data retrieved from your visit to our Website that refers to you, you must log out completely from the respective social network before visiting other websites, and possibly also delete the corresponding cookies.
- 2.10. Finally, we also use a plug-in on our Website to send e-mails. If you click on the corresponding button, your personal e-mail program opens and a connection to the server of your e-mail provider is established. We have no influence over the Data collected by your e-mail provider and in this respect refer to the corresponding data protection information of the provider you use in the individual instance.

3. Data transfer and use of Data by third parties

- 3.1. We will not transfer your Data to any third parties unless we are (i) legally required to do so, or (ii) you have given your consent thereto. The following provisions remain reserved.
- 3.2. To maintain our Website, we are required to make specific personal data available to our hosting provider, Hetzner Online GmbH, Industriestrasse 25, 91710 Gunzenhausen, Germany. With respect to this so-called contracted data processing, these service providers are also contractually bound to process your personal Data for the same purposes as we do and in compliance with the respective statutory data processing provisions (incl. the required security measures).
- 3.3. Within the context of the further provision and processing of the services requested by you, your Data may under certain circumstances also be transferred abroad. Please note that in foreign countries the retention, processing and transfer of personal data may be subject to rules other than those applicable in Italy. In such cases we will put in place the required contractual safeguards to ensure that any recipients abroad are bound by the same data protection standards.

4. Information, correction and deletion

You may at any time request information on the Data saved about your person free of charge by using the contacts mentioned below. You may also request the deletion or correction of your Data, or may object to the processing. Your Data will then be erased or blocked without delay, unless there are statutory data retention obligations or legitimate interests on our part that outweigh your interests on a case-by-case basis; in such cases the Data will be stored but not processed until the retention obligation has expired. You also have the right to complain to the competent supervisory authority if you are of the opinion that the processing of your personal Data is unlawful.
